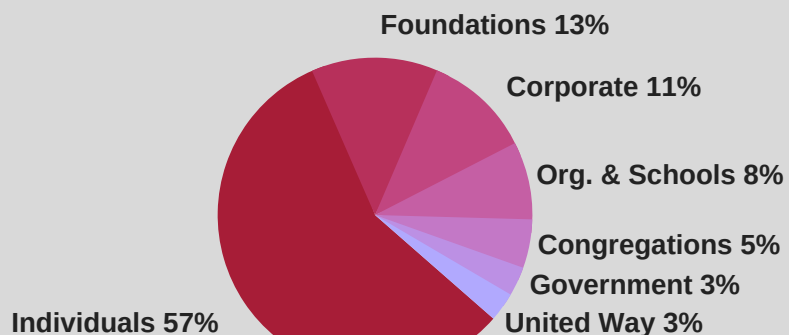

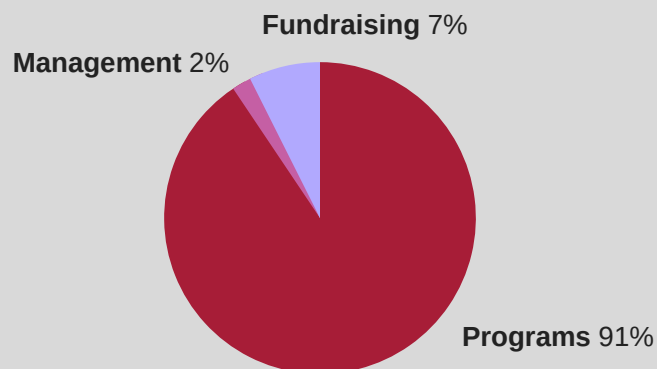
Sources of cash contributions:

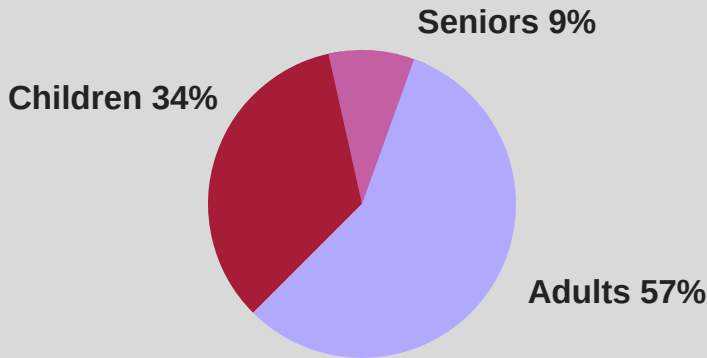

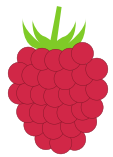
