How ICA's Case Management Team Impacts the Lives of Our Neighbors in Need



In 2018, ICA provided 982

Financial Assistance services

ICA Case Managers work one-on-one with the individuals and families who come to us for help. When neighbors visit the food shelf for the first time, they meet with our case managers to talk through how the food shelf works and what to expect when they visit. Case Managers also find out what brought our neighbors to ICA, and how they heard about us.

Our Case Managers also work with clients to ensure they are aware of and accessing other resources and services that are available to people when they need them. Common services to which we refer people include Energy Assistance, SNAP, free community meals, financial counseling and tax help, and a variety of housing, transportation, and food resources.

Case Managers also administer ICA's Financial Assistance program, which helps people with a **one-time expense** where our help will have a **significant, long-term impact**. Examples include:

- Move-in costs: security deposit plus first and last month's rent
- Helping with rent when a client experiences a gap in wages between jobs
- Transportation assistance for getting to work and doctor's appointments

Lately we've had an increase in requests for emergency Financial Assistance. We try to stay aware of the reasons people come to us for help, to identify any trends so that we can better help people. These are some of the reasons new neighbors have asked for help this summer:

- they've had a major, unexpected expense, such as a medical bill or car repair
- they (or their child) were ill, so they missed work and weren't paid
- their spouse died or left and they now have only one income to rely on

This summer, we have seen an increase in the number of people who need us. Most of our clients don't have a cushion to cover expenses when something major comes up. And that is why we are here: to help those in our community who need help. We are here for people when they need us, when the unexpected arises, to help our neighbors get back on track.

BIG PICTURE -- MAKING AN IMPACT

For many years, ICA has talked about our work in terms of the number of people we've helped and the pounds of food we've distributed. We are so proud that we have the capacity and the community support to help 800 families each month providing food to those who are hungry is such an amazing way to help people. But the true *impact* of our work is so much greater than simply providing food.

A visit to ICA means that a family can spend their limited funds on paying their medical bill or sending their children to daycare so that the parents can work. A visit to ICA can mean that families can pay their rent and stay in their homes. And by staying in their home, children can stay in their same school, providing continuity and stability, which helps kids grow up to become healthy, successful adults. A visit to ICA can mean that all children are ready to learn – that they have full tummies when they head off to school so that their growing brains have the energy they need to learn.

A visit to ICA means that our neighbors stay our neighbors. Their lives are more stable, our communities are more stable, and we can all thrive together.

ICA is here to help when people need us. What starts as a simple bag of groceries becomes so much more.

CLIENT STORY: MAGGIE'S APARTMENT FIRE

This summer, Maggie*, 37, had a fire in her home. Though the damage from the fire itself was limited to part of one room, smoke and water damage permeated Maggie's entire apartment, making her home unlivable and destroying many of her furnishings and belongings.

Maggie and her 3-year-old daughter Alice were grateful that both escaped the fire unharmed. They have since been staying with family while Maggie has worked to get their lives back together. And though Maggie's renters insurance covered some expenses, she needed help when it came to moving into her new apartment. Maggie contacted Hennepin County, and they referred her to ICA. She needed \$3600 to move into her new apartment (first and last month's rent + security deposit.) She met with our Case Manager Jessie, and came in with a plan. Between help from the Red Cross and her own financial resources, Maggie only needed \$650, which ICA was able to provide through a one-time financial grant.

Maggie and Alice have since moved in, and are working to replace their beds and bedding, furniture, and clothing. Jessie encouraged Maggie to visit ICA for food when she first moved in so that Maggie could stock her new kitchen with groceries. Jessie also referred her to Reach and Restore to help replace furnishings.

Before the fire, Maggie had never needed ICA. This one huge, unexpected crisis knocked her off course. With ICA's help, Maggie has been able to get back on track. Thank you again for supporting ICA and folks in our community like Maggie and Alice!

RMDs are simply the **minimum amount** that people 70½ or older must withdraw from their IRA accounts each year.
