Kendra first visited ICA after fleeing her home country in East Africa and arriving in our community. She initially came to ICA for a helping hand, while navigating the challenges of settling her two children into a brandnew area.

Suddenly facing food insecurity, Kendra was able to access our choice-model food shelf, which eliminated the necessity of spending time and money on grocery shopping. In addition to providing kid-friendly meals, Kendra was also able to take home culturally-relevant foods from ICA.

Now with convenient access to food, Kendra could devote more energy toward finding full-time employment. Meeting with ICA's employment specialist, she was able to receive assistance with crafting a resume, practicing interview skills and completing applications.

Currently employed by a local medical company, Kendra recently reached out to thank our team and provide a life update. Her eldest daughter just graduated college and Kendra credits ICA with ensuring her family had the necessary resources to find long-term stability.

Natalie is a single mother living in Minnetonka with her two children. She has a full-time job, although her employer does not offer sick pay. Following a serious medical diagnosis, Natalie had to miss multiple weeks of work.

Missing paychecks meant Natalie didn't have enough funds to cover her families rent and utility bills. Unsure how to bridge the gap, she turned to ICA. Our housing assistance team was able to work with Natalie and cover her rent, which ensured her family would remain under a roof and away from homelessness. She also was able to visit our food shelf, which provided her family with healthy, nutritious food in a tough time.

Back at work and financially stable again, Natalie recently reached out to thank our staff and volunteers. She says, simply put, ICA "saved" her family and she's forever grateful.
